COVID-19 Fast Response Policy UPDATE ** SUPPLY OF RELIEF STAFF **

To reiterate, Switch continues to be committed to following all measures and guidelines outlined by the World Health Organisation (WHO), the Australian Government Department of Health, Government advisory (state and national) and any local Health advisory as seen relevant.

We are continuing to monitor this closely and will adapt our policy in-line with any new directives by any of the above named.

Please note changes to clauses 1, 4 and the addition of 5

Our "fast response" policy is continually applied to daily booking requests, where by staff that may fall into any of the categories below, will be unable to accept a work assignment through Switch.

- 1) Display cold/flu like symptoms or any of the COVID-19 symptoms
- 2) Have been positively tested for COVID-19
- 3) Think they may they have been in close contact with a confirmed case of COVID-19
- 4) Travelled OS **ALL COUNTRIES INCLUDED**
- 5) Travelled recently outside the state (via plane or vehicle). This is in-line with the recent directive from SA Premier Steven Marshall (22.03.2020).

In the event a staff member falls within the categories outlined above in clauses 1-5, Switch will enforce that the individual will be unable to recommence work until such time that they have completed the required 14 days quarantine/isolation period and have been tested and cleared of COVID-19.
